"They Call the Wind Mariah." I am not certain what we should call these continuing storms but I will be thankful when I can call them "Gone!" Hopefully, you all came through these storms without physical injury. Unfortunately, it has been reported that some homes received major damage. Downed trees, debris, missing shingles, broken limbs and plants line our streets. Rock walls have also been mangled. There was damage to the storage lot on Pinecrest Drive in both storms. Power lines were down across Prospect Drive and a tree fell across Kala Point Drive just inside the gate. Community has come together as we have seen neighbors helping neighbors. Our employees are helping tree services with removal of fallen trees in addition to their regular duties of removing the storm debris. The debris piles will be picked up as quickly as possible. Please be patient. The fall and winter storm seasons will be remembered as a particularly troublesome period. Once again, I must thank our staff! Their performance has been nothing but extraordinary and they deserve our highest respect and appreciation.

Our new dock should be delivered in early April and will be installed shortly thereafter. Kala Heights Drive will be repaved this summer as well as some spot patching at the same time. Tennis court #3 will be resurfaced and made into two pickleball courts. The fencing around the sports court on Pinecrest Drive is scheduled to be replaced this summer. The Tree Committee has selected 33 people to review the revised APP II-22 within the next 3 weeks. The complete process is explained by our secretary in this newsletter.

In March, the KPOA web site and email system was moved to a new host. There is a short period of adjustment as we familiarize ourselves with all of the changes to the e-mail system. You should not notice any change on the Web page; it appears to work very well.

Important: during the week of March 14 the speed limit on Hwy 19 between Four Corners Road and the Airport Road was reduced to 40 mph. The Sheriff has stated that they will be enforcing the new speed limit. The Committee continues to work on this problem to see if more can be done.

I hope that you will soon enjoy our spring and summer seasons and pray that it will be warm, sunny, and uneventful.

## What Happened at the Last Board Meeting?

Another meeting with no pitchforks and yet again, well attended. Are you folks lulling us into a state of complacency? The meeting was not without some controversy though. The Tree Committee has been carefully and diligently working on a revision and clarification of the APP (Administrative Policies & Procedures) governing the trees and view maintenance in Kala Point. The committee has developed a preliminary version of the revised document. They carefully chose a small group of owners to preview the proposed changes and provide comments. suggestions, and other input to the committee before it finalizes the changes/ clarifications. The "beta testers" were selected from a cross section of our community. Some were view lot owners, some without views, some were members of other pertinent committees, others the current president and past presidents of the Board. Overall, twenty-seven preliminary copies were distributed. They were asked to review, comment, and return the documents within 30 days. After reviewing the input from the "beta testers" the Tree Committee will create a final draft to be submitted to our lawyers for a review to assure compliance with the CC&Rs. The legally approved draft will be submitted to the Board. At that time the Board will make the proposals of the Tree Committee available to all KPOA members, allowing a reasonable time for community input, and after due consideration of all comments and suggestions, a final version of APP II-22 of the Kala Point APPs will be voted upon. Admittedly, it has been a long process but a process that requires careful deliberation so that it is done right. There is little likelihood that *everyone* will agree with (or like) the outcome. What is important is that we follow the existing governing documents. Remember, we did not set out to change the APP, only to clarify it.

Sometimes, your Board seems to get out of one pickle only to become immersed in another. That is just what happened at our March meeting. A decision was made to move up the scheduled resurfacing of tennis court #3 and replace this little used amenity with two resurfaced and re-striped pickleball courts. Even though pickleball is one of the fastest growing sports in the country and its main attraction is that it is less strenuous, more easily played by older athlete wannabes, produces fewer injuries, and already has nearly 30 participants within the gates of Kala Point, the conversion from tennis court to pickleball courts was not without controversy. You would think it was a rivalry between tennis players and pickleball adherents. Not the case! The sides, both for and against, were made up of pickleballers. Some folks thought that if the new courts did not exactly meet the International Pickleball Federation's specifications, the conversion should not go forth. The courts will come up short by about 18 inches on each end of their recommended 60-foot length. To get us out of this pickle we relied on our insurance carrier's assurance that the 18-inch shortfall would cause no additional liability, probably since, at our ages, running 18 inches less (multiple times) is a desirable thing, not a liability, and should be encouraged. The Board voted to go forward with the conversion. They will be known as "The Short Courts for Seniors by the Lagoon."

The mailing invited the neighbor to join a free, private online network called Nextdoor Kala Point (part of nextdoor.com) in order to "share service provider recommendations, items for sale, safety concern, local events, and much more..." The mailing included an "invite code" set to expire in seven days.

Nextdoor.com is a social networking site that debuted five years ago. It is not accredited by the Better Business Bureau and there have been many complaints about the site administration.

### **Bud's Weather Report**

It is with great sadness that the Publications Committee is retiring the Weather Report. Bud Babcock died peacefully at home in the presence of children and grandchildren on March 28. He compiled weather data for the Kala Pointer beginning July 1989, and never missed an issue in 26 years. Additionally, he published an Annual Weather Report for Kala Point, which last January marked his 25<sup>th</sup> entry.

Bud was a part of Kala Point history, but that's not all. A graduate of MIT, he was a captain in the Army Corps of Engineers in the 1940s, and worked on the Manhattan Project in Oak Ridge, Tennessee. He also served on the Atomic Energy Commission in the early 1950s. He worked more than 30 years in the private sector as a chemical engineer. Bud was a member of high standing in the East Jefferson Rotary Club, a past board member of KPOA, and recently awarded the Distinguished Service Award for his long years of service on the Publications Committee.

We are fortunate that Bud chose to live here in his retirement. His hobbies included photography, astronomy, and weather studies. He exhibited his photos in the Clubhouse photo shows, and contributed astronomical tidbits in his weather reports.

We are grateful for all his years of dedication to not only the newsletter (also as layout and copy editor), but to all his other endeavors.

## **Another Invasive Species**

In addition to our previous article on Scotch Broom, we have discovered another invasive species here in Kala Point. This time it is Butterfly Bush or Buddleia, a common plant favored by many gardeners in the mistaken belief that butterflies are attracted to their gardens because of it. According to the Washington Invasive Species Council, it likely negatively affects native butterfly populations.

Butterfly Bush is primarily a woody perennial shrub with purple flowers although hybrids exhibiting shades of white



to purple have been developed. It is an ornamental plant popular with gardeners and sold in many nurseries. It is deciduous and has arching branches that can reach a height of 15 feet. The leaves and stems are typically hairy and are often green or bluegray above and whitish on the underside. The small fragrant flowers have an orange-yellow eye and are clustered together in groups that may be 4-10 inches long.

Escaped invasive populations of Buddleia are pervasive in Western Washington and Oregon. It is common along riverbanks and river gravel bars where it outcompetes native plants such as willows and also alters soil nutrients. Buddleia has also been found along roadsides and in areas that have been burn sites. It has become very aggressive in certain situations and is classified as class B noxious weed in both

Washington and Oregon. A class B classification means it must be eradicated in the wild but not from peoples yards

The variety of Buddleia that produces the most viable and prolific seed production is Buddleia davidii, the wild species. There are Buddleia davidii cultivers that produce much less seed than others. Cultivars 'Summer Rose' and 'Orchid Beauty' produce 20 times fewer seeds than 'Potter's Purple' and 'Border Beauty.' A single flower cluster of 'Potter's Purple' produces more than 40,000 seeds. Because of the low seed production of some cultivars they would have a lower potential for escaping gardens and colonizing natural areas.

So why should we in Kala Point care? Butterfly bush can escape gardens and shrubby thickets, can exclude all other plants, and displace native vegetation. They can supplant other plants as nectar sources and thus reduce their pollination. Once established these plants are difficult to remove because they re-sprout very easily. If you have butterfly bush on your property or are planning on planting some soon, there are ways to keep it in control. Don't let it go to seed by clipping off all flower heads in the Fall. Do not wait until Spring when the seeds are actually dispersed. Do not leave the clippings on the ground as they will easily take root. The best alternative is to replace a butterfly bush with a native plant. The Oregon State University Extension Service Master Gardener Program no longer recommends planting it in gardens.


