In the past couple of years during my presidency, the KPOA Board and its committees have really done a great job of making Kala Point an even more outstanding place to live. During that time the Board took your pulse through a survey that had a higher response than any other plebiscite KPOA has ever had. And we responded to what we found out, too.

We have new hang tags that mean you don't have to use a sticker on your windshield and that you can give your guests' vehicles identification without going to the office. We have new parking policies that mean your guests don't have to have vehicle identification unless they are using the sport courts, the beach, or the trails. But remember, guests still must be accompanied by a member to use KPOA amenities.

We have established closer relations with various parts of the county government including the PUD to enhance their service of Kala Point. We are working with the PUD to solve water supply challenges during a disaster. We invited law enforcement to give a seminar on fraud and crime prevention. We have further tightened relations with East Jefferson Fire and Rescue. The Fire Chief has spoken to Kala Point twice to help us understand how to make Kala Point fire resistant and he will have EJFR practice at least annually at Kala Point so they will be better prepared to help us during an emergency. Members throughout Kala Point are volunteering to have EJFR triage and practice on their property. And, not inconsequentially, the Potato Bake Chili Cook-off has for each of the past two years raised more than \$3,000 to benefit EJFR. Our relations with the Jefferson County Department of Emergency Management are very good.

What Happened at the June 2019 Board Meeting?

Your KPOA Board met at 1 p.m. for about 2.25 hours on Tuesday, June 11, 2019, in our KPOA clubhouse. Seven members were present while Dale Moses was a call-in. David Miller was absent. When we started there were 10 folks in the audience. Meeting documents were available prior to the meeting on the KPOA website (at "Board Meeting Files" under the "Members" pull-down menu).

- There was one input from the audience at the beginning of the meeting concerning changes to the APP for the Publications Committee.
- Our monthly correspondence secretary prepared a report totaling 10 inputs which you can see by clicking here.
- In addition, President Joe read a response from our lawyer to further define guests at KPOA: "If someone is not in the company of a member, they are not a guest. Consequently, any person not in the company of a member while using KPOA facilities, amenities, or common areas would be trespassing."
- Keith discussed some selected results of the new entrance/exit gates based on watching video. Over several selected periods, he counted 459 cars entering with only 13 tailgating (3%) and 15 cars turning away. With the old gate, in a period sampled on May 11, we had 68 vehicles entering with gate openings, but another 64 cars tailgated in! (94% tailgating!)
- Keith proposed amendments to APP II-19A and 19B concerning gate transmitters, but they were tabled until the next Board meeting.
- Keith listed some grounds maintenance violations that he has handled.
- A motion was passed to simplify the Board responding to communications inputs (APP II-27).
- A motion was passed to add some basic ethical standards for Board members (APP II-A)
- The summer election mailing will include three visitor parking passes to each owner.
- An Ad Hoc committee to deal with fire fuel suppression was authorized.

To our new neighbors and "old" friends: Before you undertake any projects that affect your home's exterior or make permanent changes (other than foliage) to your landscape, please review the community's governing documents, Administrative Policy and Procedures, APP Article III-2, Architectural Committee, Modifications to Existing Homes. The Architectural Committee reminds you that with few exceptions, any change, addition or alteration to the exterior of your home or your landscape (other than foliage) must be approved **in advance** by the Architectural Committee. APPs are available on the KPOA website under "Governing Documents" or you may obtain a copy from the Administration Office.

Met June 6, 1:30 p.m. Main topics of discussion were 1) Status of tree cutting in the Southern sector (2018), 2) Review and distribution of the 2019 Geotech report; 3) The status of current requests from the Central sector, 4) Recalculate estimated cost of tree actions, 5) Review timeline for the remainder of the year, and 6) Make final changes in our 2019 tree requests prior to issuing RFPs for arborist and habitat management plans. Next meeting is Friday July 28, at 10 a.m. in the KPOA Administration Building.

Main topics of discussion were 1) Planning for Candidates' Night, 2) Timeline for activities through the election in July, and 3) Establishing the next Election Committee in terms of members and chairperson. Emergency Preparedness

In June EPC hosted two presentations for Kala Point residents related to safety:

Chief Jim Walkowski from East Jefferson Fire Rescue discussed "Improving Neighborhood Resilience to Wildfire" on Thursday, June 13.

Jefferson County Sheriff's Foundation and Kitsap Bank conducted a seminar on Crime and Fraud Prevention on Thursday, June 20.

Chief Walkowski visited Kala Point on June 5 to survey potential areas for EJFR wildfire training. EJFR would like to conduct several firefighter training

exercises this summer, practicing techniques such as hose deployment and home triage. EPC will help identify homeowners who would be willing to support these exercises. EJFR will meet with those homeowners to describe what is involved and secure their agreement.

EPC conducted a training session for Block Captains on how to lead their Map Your Neighborhood parties/zone meetings. Many zones held summer "block parties" on Friday, June 21 or later, to get neighbors together socially and refresh residents on where to meet and what to do in a disaster.

At its last meeting, EPC reviewed materials related to the proposed Cassandra cache of emergency supplies, including a rationale for the initiative. The proposal will be reviewed by the Finance Committee and the Board.

Personnel

DEM managers have been here several times to encourage our Emergency Preparedness Committee with ideas for making Kala Point resilient in case of disaster. For the first time, last year more than 200 KPOA members participated in the statewide Great Shakeout emergency exercise. We're planning to do it again this fall. And we have more than doubled the number of KPOA members who are CERT qualified (Community Emergency Response Team trained through FEMA).

To help us help ourselves, the First Aid Committee is offering free first aid courses for everyone in Kala Point. More advanced free courses and first aid kits are provided for members of the First Aid Team which still needs more members; there should be at least two trained volunteers in every zone throughout Kala Point.

EPC has formulated a long-range plan specifically for Kala Point disaster preparedness called Cassandra and established its own website for important disaster information. We have instituted machinery training for an EPC team so that KPOA can function during a disaster when staff members won't be available. We have strengthened our emergency radio network that includes twice as many licensed ham radio operators as before so that we can communicate with state and local officials when phones and internet are not working. We have established an emergency preparedness communication and secure electronic document storage program that works even in situations without electricity or cell service. KPOA has provided handheld ham-quality radios for every neighborhood and for every First Aid Team member for communication within Kala Point. Additionally, we have distributed hundreds of low-cost FRS short-range walkietalkies for communication within neighborhoods when other services are unavailable. The EPC will move its Neighborhood Operations Command and Communications Center from the second floor of the earthquake-susceptible Administration Building to a new separate ground-level home.

We have brought Kala Point into the electronic twenty-first century. The Board Meeting agenda and supporting materials are now available online for all members to review prior the meeting; and incidentally, there are now two opportunities on the monthly agenda for members to speak to the Board. The *Kala Pointer* has improved substantially and is being produced using up-to-date software; its delivery is now electronic. We have become entirely electronic in voting.

We use electronic emails for important mass notification. We have established an SMS emergency

texting system for up-to-the-minute Kala Point-centric notifications.

Our streets have been maintained no matter what the season and no matter what the weather. The Clubhouse has been revitalized with new furnishings and flooring; the locker rooms have been freshened. The pool and jacuzzi have been redone. Lighting throughout KPOA is being replaced with LED to lessen our carbon footprint.

And most obviously, we have a shiny new fastoperating gate.◆

Help EJFR Help Us: Wildfire Training Exercises in Kala Point

More than 70 people attended Fire Chief Jim Walkowski's recent presentation on improving neighborhood resilience to wildfire. Chief described western Washington's increased level of risk ("something is changing"), how wildfires are impacted by wind, topography and fuel, how firefighters combat wildfires, and, most importantly, what Kala Point homeowners can do to protect their property and mitigate their risk. Chief's presentation and supporting materials are posted on the EPC website at epc.kalapoint.org; be sure to check them out!

This summer we have an opportunity to put theory into practice, and our wildfire knowledge into action.

East Jefferson Fire Rescue is working with KPOA and EPC to stage several training exercises here in Kala Point this summer. During the exercises, each of which would last a couple of hours, EJFR and several other agencies will practice wildfire suppression techniques such as laying out hoses and conducting home triage (determining which homes are defensible). The training enables firefighters to earn their "red card" in combating wildland fires.

And here's the asks: Would you allow EJFR to access your yard during the exercises to practice their techniques and also "triage" your home as to how defensible it would be in a wildfire situation?

In exchange for letting firefighters on your property, you'll learn how EJFR perceives the risk to your home and how you might go about remedying that risk.

It's a win-win. The more EJFR knows about our community, the better they will be in fighting fires here. And the more we know about the risks EJFR sees here in Kala Point, the better we will be at mitigating them.

We're looking to recruit several clusters of homes to serve as the sites for these exercises. Interested property owners would meet with EJFR to review what is entailed and give EJFR permission for access of their personnel and equipment. EJFR is particularly interested in training in wooded and/or sloped areas. Needless to say, we have lots of those in Kala Point!

More than 30 people have signed up, but we need more volunteers. If you're interested in supporting EJFR and Kala Point, contact EPC Chair Anne Englander at anne.englander@gmail.com or 360-316-9339. We will be working with the Chief to set up these exercises and will reach out to willing residents with more information. Help EJFR help us! Sign up now. ◆

Warring newsletters concerned me. I wanted openness and to get along with neighbors. I didn't want contentious nastiness. Had we made a mistake in choosing Kala Point? Newsletter tension subsided; we moved in 2011, and I get along well with wonderful neighbors.

I continue reading the *Kala Pointer* but am discouraged by decisions that squash/bury information that doesn't conform to Board perspective; is this a repeat of 15 years ago?

I have personal letter/article examples, but I'll focus on the proposed amendment to Publications Committee APP XIII.

"The *Kala Pointer* is the official conveyance to the community of Board (wording changed at the Board Meeting to KPOA) information...and articles that do not intrude upon Board business...." -- italics mine.

PC Board representative Pat Miles explained that this addition ensured conveyance, without confusion, of the Board's official view. Surely a disclaimer would suffice? Fortunately this egregious statement was removed before the vote – but why was it there to begin with?

And regarding Letters, they: "...will be limited to one letter and one response per subject." But, what if a decision/event triggers various perspectives? Isn't the *Kala Pointer* the place to communicate, especially as our online Forum is gone? Given that newsletters are no longer mailed, and printed copies are limited, the stated "space saving" rationale is weak.

Why control and curtail communication? This will create hostility much like it did in the past. Fortunately the Board amended the amendment before voting and "will" was changed to "may." The intent, though, concerns me. We need to encourage not discourage Member involvement.

Obviously, the new gate is in place and operating. Like all tools, how effectively it operates is highly dependent on its users. We're more accustomed to hearing "operator error" associated with high tech than with hammers, but believe me operator error with a hammer can make you feel "all thumbs!" It's really easy to observe operator error at the gate, too. Using the gate properly will make it even more effective and, in truth, it is your responsibility as a member of KPOA.

Most of the problems at the new gate are caused by impatience. Impatience causes people to run a red light and, before the traffic light has turned green, rush through the gate before it is fully open. That means that the gate is still going up after your vehicle clears the gate; the gate does not come down until it has fully risen. Although the time to close is very quick, the addition of the time it takes to complete its rise means that such impatience creates a situation that allows time for tailgating. In other words, residents' impatience contributes to an increase in tailgating. Use the gate properly. Wait for the light to change to green. Take just a second or two to think about how much you'll enjoy being in Kala Point, look down our nicely maintained street surrounded by refreshing green and smile knowing that you live here. Take a deep breath, wait a second, and let the gate do its thing.

An associated act of impatience is pushing the button on your remote gate opener before you cross the speed bump at the gate house. It doesn't do anything for you except raise your anxiety. It won't raise the gate for you. A vehicle must cross the speed bump before the gate will open. If you push your button when a different vehicle is in position, that person becomes your registered guest and you are totally responsible for them. Purposely pushing your button because you are impatient so that you allow another vehicle at the gate to enter when it doesn't otherwise have the ability to enter, creates rather than solves a problem. The purpose of the gate is to limit access to Kala Point to those who have been specifically granted that access either through their membership, their residency, or by being a guest. The gate is the front door for all of Kala Point; don't take it upon yourself to unlock and open someone's front door.

Another aspect of impatience is wanting to have convenience. Some members have decided to purchase in-vehicle remote transmitters to use in place of KPOA-issued devices. Technically this requires a duplication of a device issued by KPOA and such duplication is prohibited by KPOA APPs and was generally not

possible with the new DoorKing® system. However, to accommodate those members who want to use such vehicle remotes, the Board decided to make available remotes which are known to program HomeLink® systems, the dominant system that did not interface with our new DoorKing® system. These are, indeed, available for your convenience to purchase at the Administration Office. As an alternative, you can use the older Elite® remote issued by KPOA which does work with the DoorKing® but which may not program your vehicle, or you can buy a newer less expensive DoorKing® remote that also may not program your vehicle entry system, or you can use the inexpensive white keycard. Since you have to pull your vehicle forward at the gate house so that the front tires cross the speed bump no matter what entry system you use — vehicle, remote or keycard the keycard seems to offer as much utility as the more expensive vehicle programmable remote. Which of these four openers you use is your choice, none takes any longer than inserting your key and opening your front door, so relax—you're home. •

In a related incident...

Port Townsend Police Blotter

Dateline: Saturday, June 15, Kala Point A driver attempting to "tailgate" into the private, gated community of Kala Point misjudged the gate arm's timing and speed. The gate's arm descended quickly as the vehicle was attempting to pass through the gate. The arm came down on the vehicle's windshield. The vehicle sustained minor damage but the gate's arm was bent and its weather seal compromised. The arm had to be replaced.

The newly installed gate operates faster, with more sophisticated sensors to prevent more than one vehicle from entering the property at a time. When asked about the incident, Kala Point General Manager Keith Larson commented, "When we installed the new gate system we notified our Kala Point members and timeshare guests that they must avoid tailgating."

Damage to the gate is the responsibility of the driver. The damages to the gate arm are estimated to be approximately \$750 to \$1,000.

Hypothermia: The Basics

Did you know that hypothermia can impact people of all ages? It can also be a concern year-round: winter, spring, summer and fall.

According to the Mayo Clinic, hypothermia occurs when your body loses heat faster than it can produce heat and your body temperature falls below 95 degrees F. Left untreated, it can be life-threatening.

Hypothermia is often caused by exposure to cold weather or immersion in a cold body of water. Older people are at risk of hypothermia not only in cold weather, but in mildly cool temperatures as well. Cold weather can be a problem for older adults because many take medications that can interfere with the body's ability to regulate its temperature. Medications that increase the risk of accidental hypothermia include drugs used to treat anxiety, depression or nausea, and some over-the-counter cold remedies. Ask your doctor how your medicines affect body heat.

Signs and symptoms of hypothermia usually develop slowly and may include:

- Shivering, (may stop as body temperature drops)
- Slurred speech or mumbling
- Slow, shallow breathing
- · Weak pulse
- Clumsiness or lack of coordination
- Drowsiness or very low energy
- Confusion or memory loss
- Loss of consciousness

If you suspect someone has hypothermia, call 911. Then immediately take these steps:

- Gently move the person out of the cold. If going indoors isn't possible, protect the person from the wind, especially around the neck and head. Insulate them from the cold ground if possible.
- Gently remove any wet clothing. Replace wet things with warm, dry coats or blankets.
- If further warming is needed, do so gradually. For example, apply warm, dry compresses to the center of the body: neck, chest and groin.
- You can also use your own body heat to keep the person warm. Keep them in the horizontal position. Lie close to the victim but be gentle.
- Offer warm, sweet, nonalcoholic drinks. Do not give them alcohol or cigarettes.

(Rubbing the person's arms and legs, as many rescuers are tempted to do, can make the problem

worse as it may cause cool blood that had pooled in the extremities to return to the circulation and a further drop in core temperature.)
