You are about to elect new members to your Kala Point Board of Directors. This is a good time to review what the outgoing Board has accomplished. I'd like to start by thanking my eight fellow Board members – Dale Glantz, Caroline McNulty, Michael Machette, Pat Miles, David Miller, John Oliveira, Steve Reed, and Kim Titus – for dedicating their time for the betterment of Kala Point. But it should go without saying that most of what the Board accomplishes is in fact done by our Committees and what our Committees accomplish is in fact done by you and your neighbors. Any review of this Board's accomplishments are a review of our Kala Point Owners' Association accomplishments. At the outset of its current term the Board set six major goals and I am very happy to report that all of them were accomplished:

- On-going positive financial management of current reserves and operating accounts
- Assure the safe operation of fire hydrants throughout Kala Point
- Implement annual community-wide first-aid courses
- Implement semi-annual EPC Block Meetings and Emergency Exercises
- Complete the revision and update of the Architecture Committee APP
- Improve and update the KPOA website

We couldn't have accomplished our financial management goals without the Finance and Internal Controls Committees, especially John Oliveira, our CFO, along with Maria Mendes and David Harrah. Besides continuing to undertake the duties that you might expect of each committee—Trees looked at trees, Architecture looked at architecture, and so forth—almost every committee revised at least some part of its Policies and Procedures.

Additionally, some Committees made especially noteworthy accomplishments. The Elections Committee progressed us to the twenty-first century by instituting all electronic balloting, just as the Publications Committee has moved to almost exclusive electronic publishing. Social Plus broke new ground by hosting a Composting Seminar in conjunction with Jefferson County. With EPC, Social Plus raised over \$3400 for East Jefferson Fire and Rescue to buy equipment that can help us in emergencies They also managed to host very successful celebrations of Thanksgiving and New Year's—not to mention to the Community Garage Sale and Block Party. We're all looking forward to what they can do with the Bastille Day Hawaiian Beach Party, too. The Tree Committee has undertaken a unique and very forward-looking attitude by seeking to

Board Notes June 12, 2018

Greetings! Happy summer to all of our Kala Point residents! The weather is stunning, the pool is heated, and the outdoor courts washed! I hope you are enjoying time outdoors. I'll be outside as soon as I finish the Board notes!

The meeting in June was preceded by a compliance hearing, requested by the Tree Committee. A number of residents joined us for the hearing and the result was a solution that was satisfactory to all parties. The regular meeting then began at 1:00 pm.

Joe Englander and Caroline McNulty shared that an inquiry had been sent by a number of residents concerning the tree clearing done on lot #116C. The Architectural Committee and President Joe met with those residents and answered questions and discussed intended outcomes. The comfort level is higher as a result of the meeting.

General Managers Report

First, many thanks go to all of our residents for promptly paying the 2018 assessments.

As always, our amazing Kala Point crew is cranking out the work. Keith shared that the membership pamphlet for this year's elections has been sent to "Elections Trust" for mailing. It will be mailed hard copy and will include instructions as to how to vote on-line. Included in that transmittal is the KPOA Eligible Voting Mailing list, which has been updated.

Keith shared that Kala Point will again have Security Services patrol Kala Point in July 4 from 4:00 to 11:00 pm. This is to ensure that fireworks are not used within the subdivision. He also shared that based on the feedback from a very successful community-wide garage sale, KPOA will place two portable restrooms at two locations to help with the large volume of people visiting during the annual event.

The projects recently completed (and under budget!) include: Terrace Drive paving, Clubhouse flooring and the new gravel on Storage Lot B. All of the tennis and pickle ball courts have been power washed. Projects still on the rolls for 2018 include new clubhouse furniture (recommendations will be presented at the September Board meeting), our annual road maintenance, new roofing on the Sailview Drive and Foxfield Drive mail sites, and the tennis court resurfacing project.

A motion was brought forward to the Board to add pickleball court lines, in green, to tennis courts 1 and 2. This would result in two full-time tennis courts, two full-time pickleball courts, and two courts that would have lines for both. The intention is to have courts available for those times when the pickleball courts are full and the tennis courts are not being used. The additional lines would be added during the

engage a silviculturalist to analyze the health of our community's trees holistically. Maybe by looking so closely at the health of individual trees, we've missed the health of our "forest." Good idea!

One of the main concerns of this Board has been the safety of you, our members. No one committee epitomizes this concern more than the Emergency Preparedness Committee with its First Aid subcommittee. First off, they made certain that Kala Point has two Automatic Defibrillators on site for the kind of emergencies that can happen anytime to anyone. And then they offered training – training in how to use AEDs, training in how to use first aid equipment, and training in how to use KPOA equipment we might need in emergencies such our tractors, chainsaws, and trucks. And then they instituted an emergency communication system that begins at the home level with FRS radios, goes up to the Block Captain level with commercial radio communications, and then escalates to ham radio for contacting the outside world when phones and internet are out of service in an emergency. Every month, they test and use the radio systems. And they are going even further by seeking to make certain that Kala Point residents will have an independent supply of food, water, and first aid in the event of a catastrophic disaster. These are your neighbors working to assure your safety!

I hope you will join me in offering sincere thanks to each of the Board Members for their service and to all the Committees and their members for making Kala Point the kind of place where we all want to live.

resurfacing project for tennis courts 1 & 2. There were a number of residents interested in the proposal. The affected condo owners were concerned about the noise that they experience now from the pickleball courts and the additional play closer to the condos would exacerbate the issue. Tennis players were concerned that the relined courts would be monopolized by pickleball players and no longer be available. The Board approved adding pickleball lines to court 1 & 2 provided that: 1) All courts would have the same sign-up procedure, making courts available for everyone; 2)

Pickleball play will be limited to 9:00 am – 5:00 pm, to reduce noise concerns; and 3) a tennis player could assist in determining the intensity of the green colored lines, to assure interested parties that the lines could be differentiated during play.

Keith has received an inquiry about installing lane ropes in the pool all day to separate lap swimmers from kids playing in the pool. Given *there is* lap swimming time in the morning and evening, the pool is one of the top attractions for timeshare owners and guests, and the pool isn't very wide, we want to have the entire pool available for open swimming during the afternoon.

Keith also shared that the maintenance folks were periodically checking for Kala Point stickers at the beach parking lot at his request. Please make sure you have your sticker on your vehicle when visiting the beach.

Committee reports:

Architectural – Board passed a motion to add a new member, Caroline McNulty, to the committee in July. Caroline's time on the Board expires after the elections and is interested in continuing her service on the AC.

BMAC – The board passed two motions: 1) to implement a fine for unauthorized tree trimming and 2) to add two new members: Bob Winfrey and Hugh Musser.

Elections – June 13 the community got a chance to meet the candidates for the Board. All three are excited about participating, have a variety of backgrounds and will be great additions to the Board.

EPC – Mark Miller, volunteer at Jefferson County Emergency Operation Center (EOC) and Kala Point resident, gave committee members a tour of the center. They learned how the EOC works in an emergency. They will also put an article in the Kala Pointer every month on different aspects of building an emergency kit. Kala Point also has established a radio net that tests twice a month. This would be put into place if the phone were down. The Kala Point Emergency Preparedness Expo is September 15 and will feature lectures and exhibits.

Finance and Internal Control – The Board passed a motion to adopt the updated APPs, which have been crossed-checked between the two committees. John Oliviera clarified the resolution in the

There are bins for corrugated cardboard, bins for paper, bins for glass, and bins for plastic and cans. There are no bins for refuse, trash, yard waste, or garbage. Each of these bins has an easily readable sign explaining what should go in them and what shouldn't. The bins don't have monitors. What they do have are consequences. They are not there as a charitable action; they are there because Skookum expects to make some dinero by recycling what you don't want. If they can't make money, we won't have the convenience. It's that simple.

When careless individuals contaminate the recyclables with food and garbage, with plastic in the glass bin, with Styrofoam in any bin, then that whole load becomes worthless. Volunteer now to help Kala Point prepare for emergencies

The Kala Point Emergency Preparedness team is looking for three types of volunteers; read on, decide how you can help, and give us a call.

Assistant block captains: Are you able to walk your block? Can you tell when a tree has fallen through a roof? Can you read a sign in a window calling for help? Then you're qualified to be an assistant block captain and you are needed! Every one of the nineteen Kala Point Zones needs to have a block captain, and an assistant to fill in when the captain isn't available. The duties are simple but extremely important to the Emergency Operations Plan for Kala Point. In a disaster, your primary job is to help assess your immediate neighborhood, see if someone needs help, and report it to our Emergency Operations Center by a radio with which you will be provided. So please, volunteer to be an assistant block captain by calling Mark Miller, Block Captain Lead, 360-774-5005.

First aid team: Were you a Boy Scout or Girl Scout? Cub Scout or Brownie? Did you play doctor or nurse? Were you a real one? The Kala Point First Aid Team needs volunteers who are willing to respond to neighborhood emergencies in a disaster. Ideally, Kala Point should have at least one emergency first aid responder in each zone. Right now, there are only a few for all of Kala Point. In the event of a disaster when ambulances and EJFR are not available, we'll need to have responders to help our neighbors survive injuries or illnesses. You don't have be a doctor to know how to stop bleeding or splint a fracture. If you're willing to help, we're willing to train. Please volunteer to Terry Rose, 360-385-1940.

Pet emergency management team: Do you like animals? Do you have pets or know friends in Kala Point who do? Then we need you to help pet owners prepare for potential emergencies, and to assist distressed or lost pets during an actual disaster. And, if you're interested, you can become part of a network of pet-lovers who assist one another on a short-term basis when, for example, a pet owner is hospitalized needs someone to check on a pet. WILL YOU BE ABLE TO COMMUNICATE IN AN EMERGENCY?

At its June meeting, your Emergency Preparedness Committee (EPC) discussed ways to help Kala Point residents become better prepared for an emergency. The EPC decided to highlight in each month's Kala Pointer an item that would enhance your Emergency Preparedness kit. Those EPC team members who had experienced an extended period of time without electricity — whether from a strong winter storm, an earthquake, or living in a hurricane or tornado corridor — related that the lack of information about what was happening inside and outside of their immediate neighborhood was the hardest thing to cope with. Silence. No phones, no radios, no television. So, this month we're highlighting **Communication**.

Within Kala Point

In early 2018, the EPC implemented a program to place an EPC-programmed walkie-talkie into every home in Kala Point. The programming allows you to talk with the neighbors in your immediate zone during a disaster (Kala Point has 19 zones, with a Block Captain assigned to each). This will be your first line of communication to know what is going on in your immediate area. If you have an emergency or just need help, you can relay that information to your Block Captain on the walkie-talkie. Via the Kala Point communication network your Block Captain would transmit pertinent information to the Kala Point Emergency Operations Center (KPEOC) which will be activated in the KP Office during an emergency. They, in turn, can relay information to the KP First Aid Team or volunteers who are willing to help in an emergency. Through our network of HAM operators, the KPEOC can also communicate with Jefferson County emergency mmanagement.

If you have not obtained your Kala Point walkie-talkie, you can purchase one for \$10 through your Block Captain. It will come pre-programmed for the zone in which you live. In a disaster you will only have to turn it on (press/hold the "on" button for 3 seconds) to request help, see if your neighbors need help, or report that you are OK. If you don't know your zone or your Block Captain, check the Kala Point website (under Forms/Documents, Committee Forms & Documents, EPC) for a zone map and list of EPC team members.

Beyond Kala Point

Beyond Kala Point, one of the best ways to ascertain conditions on the community or county level is to own an AM/FM/NOAA Emergency Radio. There are many brands (Running Snail, Greadio, Kaito, Red Cross, Eton, LL Bean) but most are similar, if not identical.

One model of a Running Snail radio can be charged via USB, solar or by cranking. It has a flashlight feature and a 1,000 mAh USB port to charge a cell phone. The Running Snail is currently available on Amazon for \$19.90.

A Greadio model charges via USB, solar, cranking or 3 AAA batteries. It also has a flashlight/reading light feature and a 2,000 mAh USB port to charge a cell phone. It is currently available on Amazon for \$29.90.

Similar radios are available at Big 5, REI, Costco, and Walmart, to name a few. Choose one whose features and budget fulfill your need.

Be prepared! Make sure you can communicate with neighbors and know what's going on in our area; stock up now on your walkie-talkie and your emergency radio.

Opportunity

East Jefferson Fire Rescue, EJFR, will test for volunteers and Volunteer Resident firefighters on Thursday, July 12 at 5 p.m. The testing process will include a written exam, physical agility test and interview.

Volunteers can fulfill a variety of roles with the Department, including firefighting, station maintenance, public education, tender operations (drivers) and EMT response.

Volunteer Resident Firefighters typically join the Department in pursuit of a career in the fire service. EJFR pays for their training to become IFSAC Firefighter I and National Registry Emergency Medical Technician (EMT-B) certified. Volunteer Resident Firefighters usually work a 48-hour per week shift alongside career firefighters and receive a monthly stipend.

EJFR now also encourages volunteers in an EMS-only capacity and the District will coordinate and pay for EMT certification.

For candidates who wish to prepare for the agility exam, a practice test will be held on July 10 at 5 p.m. Both the practice and actual exams will be held at EJFR Fire Station 1-5, located at 35 Critter Lane in Port Townsend, next to the County Landfill.

In-District residency is not required.

Completed applications are due in the EJFR administrative offices no later than July 6 at 5 p.m.


