From the Desk of KPOA President

In the summer, the Kala Point Board of Directors formed an ad hoc committee to investigate solutions in support of pedestrian safety. At the November Board meeting, that committee made several recommendations that were approved by the Board. Some of those recommendations include:

- Removing vegetation along Kala Point Drive that encroaches into the common area easement
- Establishing where we might have marked crosswalks on Kala Point Drive
- Conducting a line-of-sight survey on curves and at intersections to determine driver and pedestrian visibility
- Scheduling town hall meeting(s) to inform Kala Point residents of their rights and responsibilities as walkers, bikers, or drivers on our roads

In addition, the Pedestrian Safety Committee is conducting a feasibility study for the purpose of creating a dedicated walking path along Kala Point Drive. Kala Point residents will be kept informed as additional information is gathered. In the end, the residents will decide if a dedicated walking path is something they support. •

November Board Meeting Summary

The November KPOA Board Meeting was held October 10 at 3 p.m. It was a hybrid meeting held in person at the clubhouse and over Zoom. Directors in attendance: M. Lannon, president; J. Reeves, vice president; D. Nordlund, secretary; K. Skolrud, CFO; and Directors M. Machette, P. Miles, D. Moses, and S. Stanton. Also in attendance were Keith Larson, general manager; and Felice Thompson, executive assistant. There were also Zoom attendees and more than a dozen in-person attendees.







A quorum being present, the meeting was called to order. The agenda for the November meeting (as amended) and the minutes of the October 10, 2023, Board meeting were approved.

It was announced that the deadline for articles for the December *Kala Pointer* was November 19. Also, because of the need for mail-in ballots this year, the results of the annual elections won't be known by meeting time, so the meeting will be recessed until 1 p.m. on December 13, 2023. Following this extended meeting, the newly elected Board will be seated and will have their organizational Board meeting.

Next, the consent calendar was passed which approved the appointment of Fred Wilson and Rebecca Carroll to the Elections Committee and Whit Porter to the Publications Committee.

General Manager's financial report

It appears that we will finish 2023 with expenses under budget. With the approval of the budget resolutions at the annual meeting, the unspent money will be credited to the 2025 annual assessments.

Grounds report

The sweeper unit for the tractor is operational, but necessary warranty repairs on the tractor delayed street cleaning. This produced delays in testing the snowplow and sanding equipment and delayed some mowing and weeding.

Tree and brush removal is scheduled along the easement adjacent to Storage Lot A.

The diver scheduled to inspect the buoy anchors at the beach found no problems with the anchors themselves, but a lashing chain had broken on one buoy resulting in the loose buoy. The lashing chains on both buoys will be replaced in the spring.

Several dead trees have recently been removed from Sailview Drive, Baycliff, and the Foxfield/Kala Point intersection.

Old business

- 1. Pacific Engineering was hired to do an analysis of the pier to determine its structural integrity. KPOA will be receiving a report from them by December 11, 2023.
- 2. The Pedestrian Safety Committee gave a report on their recommendations for improving safety. The Board adopted several of the recommendations since they were deemed low cost and capable of being carried out by KPOA staff. The committee was tasked with gathering more information on the recommendations that were not adopted, which the Board may consider in the future.
- 3. The Board adopted the "Board Orientation Package" proposed by the Project Study Committee for use in providing an orientation for new Directors (and a refresher for continuing Directors) as to how the Board functions.

There was no new business.

Committee reports

D. Moses reiterated the request from the Publications committee that directors continue to use bulleted lists to summarize their committee meetings, and to be careful with punctuation and spelling, especially of members' names.

There being no further business, the Board voted to recess until the December 13 meeting time.

In August, a KP member made a suggestion regarding announcing Board Candidate election results. The suggestion was to publicly announce names of the top three votegetters who will become the new Board Members rather than the vote counts for each candidate. The Elections Committee evaluated the concept and sees merit.

Our October newsletter article requested member input. After an email link error was discovered, a followup email blast was sent by the KPOA office. Based on member response by 100 households, 91% of the membership recommended announcing the names of the three new Board Members rather than the vote tallies for each candidate. For transparency, full vote statistics would be available at the Admin office.

The Elections Committee will continue moving forward on this concept which may include a minor APP change in 2024. Thanks so much for your comments. Stay tuned. ◆

Search and Rescue Capability in Kala Point Expanded

On November 18, the Kala Point Emergency Preparedness Committee (EPC) welcomed a new graduating class of Kala Point residents to its CERT team. The nationally recognized Community Emergency Response Team (CERT) training course, which had begun here in Kala Point just months before the COVID lockdown, had been put on hold for two and a half years, until it was finally able to resume in early October.

The course covered team operations, disaster preparedness, disaster fire suppression, light search and rescue, and disaster medical operations. With this training, EPC's Search & Rescue teams will know if it is safe to enter and how to search a collapsed







structure. If victims are found, they are trained to assess them medically and determine how best to extricate them from the building for further evaluation and care from the Kala Point First Aid Team.

Question: How do Items Get Onto the KPOA Bulletin Boards, and Who Approves them?

Answer: The general manager approves all postings on KPOA's bulletin boards. Please don't post anything yourself. If you want something posted, please send an email to the general manager at GM_larson@kalapoint.org. When he receives a proposed flyer or notice, he makes a judgment whether or not the item is of general interest to all of Kala Point. If he has a question about this, he consults the Board president (his boss).

Commercial solicitations typically would not be accepted, nor would information that doesn't pertain to our residents. Library events, public classes of interest, performances, and events inside of Kala Point would normally be allowed. All postings will have a time limit where they would be removed from the boards after a short time.

Galloping Crabs and Phantom Flounders

You have probably seen crab shells on the beach, resting there like a relict suit of armor from some medieval battlefield. Have you ever wondered what the animal was like when it was alive and roaming the seafloor? Similarly, have you looked at the crabs moping in the display tank at the seafood outlet, or the fish with a bleary eye staring upwards lying on the ice table, and wondered what they were like in their natural setting?

Here are two short videos which offer a peak into their world in Port Townsend Bay. I have been taking underwater video of the Bay seafloor for personal interest in geological issues, but along the way I have been able to capture the life that exists there. Both the







geology and biology of the Bay are diverse, and they interact.


The first video (tinyurl.com/GallopingCrab) shows a crab reacting to my video camera apparatus traveling above the seabed. I believe the animal is winded by the end of this episode.

The second video (tinyurl.com/PhantomFish) gives us a view of a flounder's world, rudely interrupted by a camera landing. It also shows the exquisite operation of local natural selection as the fish and bottom converge in appearance. This bottom type is only found in certain parts of the Bay, and elsewhere the fish would stand out like a sore thumb.

These are only fragmentary glimpses of the action below the waves. So much must be happening there, and most of us have little idea as we stand on the shore looking out over the water. •

Sharing the Good Life

This cookie was a big hit at the Newcomers' gathering. It was suggested I submit it to the *Kala Pointer*.

Almond and Cherry Amygdalota (Greek Christmas Cookies)

Ingredients

- 2 egg whites
- ¼ teaspoon salt
- ¾ cup (170g) granulated sugar
- 1 teaspoon pure vanilla extract
- 1 teaspoon pure almond extract
- 2½ cups (250g) blanched almond flour
- 14–16 Maraschino cherries, drained (preferably Luxardo or Trader Joe's Amarena cherries)
- Confectioner's sugar
- ¼ cup or more of sliced almonds

Instructions

Preheat the oven to 350° F. Line a











Beat the egg whites with the salt on high speed until frothy. Add the sugar and beat until thick and shiny.

Add the vanilla and almond extract along with the almond flour and beat until a dough has formed.

Place about a cup of confectioner's sugar in a bowl.

Take about a tablespoon of dough and form it into a ball. Roll the ball in the confectioner's sugar.

Place the balls onto the prepared pan.

Press the center of each ball down with your index finger to create a little well to hold the cherry.

Pat the cherries dry and place one cherry into the center of each ball.

Nestle a few sliced almonds around the cherries.

Bake on the center rack of the preheated oven for 15-18 minutes.

Allow the cookies to cool completely. Transfer them to a serving platter and serve with coffee. *Kali Orexi!* •

They provide a safe place for homeless, abandoned, unwanted dogs and cats, as well as offering (when they can) low-cost vaccinations, microchipping, and spay/neutering.

The Humane Society of Jefferson County, however, depends solely on money raised through services, adoptions, and of course, donations. They receive no funding from either the county or the national Humane Society. At this point in time, their financial situation is precarious, running at a deficit of \$200,000.


We Need A Minimum Vote!

KPOA is voting on lots this Fall including four votes for changes to our *Covenants*, Conditions and Restrictions (CC&Rs). Because this document is senior to virtually all our other documents except one, it has a very high bar to meet for changes - namely that 50% of our total ownership has to vote (301 owners of the 601 total) and two-thirds of that is needed to make any changes. This means that if fewer than 301 owners vote, it doesn't matter what they want...the vote fails. I am particularly interested that we regain our electronic voting method, one of the four changes proposed. Over the past decade, we have had nine times with less than 301 owners voting (out of a total of 21 voting sessions). So this year, everyone, please vote. Let's get these good changes made and make all our votes count!






