The Elections Trust, acting as your Credentials Representative for this meeting, has completed validating the list of the names of the Kala Point Owners' Association members who voted as of the 1:10 p.m. Cutoff on Sunday, December 08, 2024.

Before the Annual Membership Meeting, the Elections Trust had verified that 601-member units were eligible to vote (out of 601 total units).

A total of 339 ballots were validated, of which 217 ballots were received using vote-by-mail & 122 were received using Electronic Voting. This represents a voter turnout rate of **56.41%**, with only 20% (120) of eligible voters required for quorum purposes to hold this meeting, all requirements were easily met.
